# **Presenter Biographies**

## In Order of Appearance in the Legislative Learning Lab



Joe Dorman serves as the Chief Executive Officer for the Oklahoma Institute for Child Advocacy. Joe served House District 65 as the state representative for 12 years, which included parts of Caddo, Comanche, Cotton, Grady, and Stephens Counties. He authored key pieces of legislation for education, public safety, and government accountability. He was a candidate for Governor in 2014, and formerly served as a town council member in Rush Springs, as well as the chairman of the Watermelon Festival held on the second Saturday of August.

Joe is a board member of the Oklahoma Academy, Ground Zero, the Jasmine Moran Children's Museum, the Oklahoma Intercollegiate Legislature Foundation, and is a graduate of Leadership Oklahoma. He is a member of the Rotary Club of Oklahoma City and was selected by the Journal Record as one of the 50 most influential Oklahoma CEOs in 2022.



Hired by President Pro Tempore Greg Treat in 2018, Arnella Karges is the Chief Operating Officer for the Oklahoma Senate, managing a staff of over 130 people and executing the day-to-day activities and operations of the Senate.

Prior to joining Senate staff, Arnella was a registered lobbyist for the Oklahoma Oil & Gas Association and previously the State Chamber of Oklahoma. In her role as an advocate for these statewide associations, Arnella specialized in energy, natural resources, aerospace, mil-

itary affairs, technology, telecommunications, transportation, and ethics compliance issues.

In previous state service, Arnella worked for the Oklahoma House of Representatives in various roles including Parliamentarian and Redistricting Director for 2009-2011.



Kris Steele is Executive Director of TEEM (The Education and Employment Ministry), a non-profit dedicated to breaking the cycle of poverty and incarceration in Oklahoma. TEEM offers educational opportunities, cognitive behavior courses, life skills instruction, job training and employment placement assistance to individuals impacted by the criminal legal system. He also serves as Advisor of Oklahomans for Criminal Justice Reform, a coalition comprised of community groups, business leaders, health professionals and faith leaders dedicated to ad-

vancing effective approaches to community safety by increasing access to treatment and programs designed to address root causes of crime. Kris earned a bachelor's degree in religion from Oklahoma Baptist University, and master's degree in education from East Central University. Prior to joining TEEM, Kris served as State Representative from 2000-2012, and Speaker of the Oklahoma House of Representatives for the 53rd Legislature. During his tenure in office, he led the charge on a number of reforms in the areas of health care, human services, and criminal justice. Kris and his wife, Kellie, are blessed with two daughters:

Mackenzie (21) and Madison (20) and currently reside in Shawnee.



Caitlin currently serves as a Policy and Advocacy Director for EdChoice. In her work, she works with coalitions in key states to advance universal educational choice policies that empower students and their families.

She was born in Fort Smith, Arkansas, and raised outside of Sallisaw, Oklahoma. She graduated from Sallisaw Public Schools after attending both Sallisaw-Central Schools and Shawnee Public Schools. Caitlin earned a Bachelor of Arts degree in Political Science and a second In-

terdisciplinary degree in Math and Physical Sciences from Southwestern Oklahoma State University in Weatherford, Oklahoma where she attended on a full academic scholarship.

After graduation, Caitlin worked in Weatherford Public Schools as a paraprofessional and as a legal secretary for an Oklahoma City law firm while taking graduate classes and studying for the LSAT. Always interested in state politics, she accepted a session-only position with the Oklahoma House of Representatives as a Legislative Assistant. After spending a session working with Representative Jadine Nollan, Caitlin began law school, but was quickly offered a full-time position with the Oklahoma House of Representatives as a Legislative Assistant and transitioned to attending law school part-time. After four semesters in law school, she realized her passion was policy and state politics, and practicing law was not in her future.

Caitlin spent time as the administrator of a medical research clinic, developing the practice from strictly an FDA trial facility to possessing its own infusion clinic, lab facilities and private practice. She went on to teach math at Union and Coweta Public Schools, before staying home to raise her twins, Maverick, and Arlington. Prior to joining EdChoice, Caitlin had returned to the Oklahoma House of Representatives.



Chris Benge has spent his career serving the people of Oklahoma. As Interim Senior Vice President at OSU-Tulsa, he leads the operations and provides strategic vision for Oklahoma State University's urban branch campus.

Benge worked with his father in a small family-owned painting and construction business before serving in the Oklahoma House of Representatives for 12 years. During his time in the House, he served for three years as chairman of the House Appropriations and Budget Com-

míttee and as Speaker of the House from 2008 to 2010.

After leaving the House due to term limits, Benge returned to Tulsa to work as an advisor to Mayor Dewey Bartlett, and in 2011 he was named senior vice president of government affairs at the Tulsa Regional Chamber.

In November 2013, Benge was appointed Oklahoma Secretary of State by Gov. Mary Fallin. In February 2015, he also became Oklahoma's Secretary of Native American Affairs. Benge transitioned to the role of Fallin's Chief of Staff in October 2016.

In 2019, he joined OSU Center for Health Sciences as executive director of Rural and Tribal Health Policy at the Center for Rural Health, and in 2021 he returned to his alma mater as Interim Senior Vice President at OSU-Tulsa.

Benge is passionate about promoting the unique qualities that make Oklahoma an ideal place to live, work and play. He has represented the state on diplomatic missions abroad to South Korea and Taiwan and demonstrated his commitment to raising Oklahoma's profile on the world stage by creating a state room for international guests in the State Capitol building.



Luke Martin attended Oklahoma State University where he earned a B.S. in Business Administration. He began his career with five years on the staff of Oklahoma Governor Brad Henry, serving as a personal assistant, cabinet liaison, and deputy legislative liaison. During this time, Luke worked on a variety of issues including education, early childhood development, economic development, and public safety.

In 2009, Luke became an associate with Oklahoma Political Strategies and The Capital Group. As an associate with OPS, a campaign management firm, Luke managed numerous campaigns including statewide races, ballot initiatives, municipal elections, and legislative races. As an associate with The Capital Group, Luke lobbied for a number of issues and clients including healthcare, energy, and higher education.

In 2010, Luke established his own lobbying and consulting firm - Capital Plus. Capital Plus, a government relations consulting firm, specializes in legislative strategy and aiding clients in understanding the complexities of legislation and political realities. Luke assists in developing legislative strategies and effectively advocates legislators on behalf of clients.

Bob Blackburn, a native Oklahoman, has served as executive director of the Oklahoma Historical Society since 1999. He joined the OHS in 1980 as editor of The Chronicles of Oklahoma & became deputy director for agency operations in 1990.

Blackburn is a 1973 graduate of Southwest OSU, where he earned a Bachelor of Arts degree in history. He earned his M.A. & Ph.D. in history from OSU. Blackburn grew up in Edmond & graduated from Putnam City High School in 1969.

Blackburn published several articles & his first book while still in graduate school & has since written or coauthored 18 books & numerous articles, journal entries, & screen plays. He is a steady source of historical information to the media & has appeared numerous times on the History Channel.

He was instrumental in planning & building the Oklahoma History Center, a 215,000 square foot museum & research center. Blackburn has served on numerous national & regional boards & committees, including the Western History Association, the Oklahoma Association of Professional Historians, the AIA, & Leadership Oklahoma City.

mission, Opioid Overdose Fatality Review Board, Opioid Abatement Board, and the Criminal Justice Reclassification Council. A native of Oklahoma, Jennifer Lepard brings 20 years of experience in shaping state policy to Nova Group Consulting. Jennifer began her career as a bill drafter for the Oklahoma State Senate where she first honed her legislative experience. Following her tenure in the Senate, she transitioned to advocacy at the State Chamber of Oklahoma where she championed health care initiatives and oversaw policy development as Executive Director of the State Chamber Research Foundation. During the pandemic, Jennifer returned to public service as

the Chief Operating Officer for the Oklahoma State Department of Health and the Chief of Community Partnerships for the State Department of Education. Jennifer then returned to the private sector to form Nova Group Consulting, a full-service lobbying and government relations firm in Oklahoma City.



Jari Askins took the office of Oklahoma Administrative Director of the Courts in 2015. Previously she served as Oklahoma's 15th lieutenant governor from 2007 to 2011. Askins was born April 27, 1953, in Duncan, Oklahoma. She completed her Bachelor Arts in journalism from the University of Oklahoma in 1975. In 1980, she received her Juris Doctorate from the University of Oklahoma College of Law. Prior to serving as lieutenant governor, Askins served as the special district judge of Stephen County, Oklahoma, from 1982 to 1990. From 1991 to

1992, she served as the chair of the Oklahoma Pardon and Parole Board, becoming the board's first female chair. From 1992 to 1994, she served as the deputy counsel to Governor Walters. Prior to being elected as lieutenant governor, she also served 12 years as a state representative.

P. Kay Floyd graduated from Oklahoma State University in 1980 with a Bachelor of Science degree in psychology, a minor degree in political science, and a minor degree in philosophy. After graduating from OSU, Senator Floyd attended law school at the University of Oklahoma where she received her Juris Doctor degree.

After two years in private practice, Senator Floyd became an Assistant Attorney General for the State of Oklahoma working in both the civil and criminal divisions. In 1987, Senator Floyd accepted the position of Deputy Executive Director for the Oklahoma Horse Racing Commission.

In 1989, Senator Floyd was appointed as an Administrative Law Judge for the State of Oklahoma and served in that capacity for 22 years. Her appointment made her one of the youngest women in Oklahoma history to receive a judicial appointment. During that time, she also served as a Special Municipal Court Judge for the City of Oklahoma City.

Along with her judicial duties, Senator Floyd has been an adjunct professor at Oklahoma State University and an attorney for the senior citizens division of Legal Aid of Western Oklahoma. Senator Floyd has worked as a volunteer on the Citizens Action Committee for the Oklahoma City Animal Shelter and as a member of the Oklahoma Bar Association's Women in Law committee. She also serves as an Advisory Council Member for Palomar Family Justice Center and is a former member of ReMerge Board of Directors.

Senator Floyd has served on the OKC AIDS Walk Board of Directors and is a member of the Board of Directors of Lyric Theatre in Oklahoma City.

Senator Floyd was elected to the Oklahoma House of Representatives in 2012 and the Oklahoma Senate in 2014 where she has served as Senate Democratic Leader since 2018. While in the Senate, Senator Floyd focused on improving our education system and working for Oklahoma's women and children. She has authored bills to provide suicide prevention training in Oklahoma's schools and require potential guardians to undergo background checks.

In 2014, Senator Floyd authored the Lethality Assessment Act which made Oklahoma the first in the nation to establish such a program. In 2019, she authored legislation to address Oklahoma's backlog of untested rape kits through standardizing the guidelines for testing rape kits and creating a statewide tracking system for collecting sexual assault evidence. The legislation also expands continuing education for law enforcement on how to properly address sexual assault reports.

Senator Floyd currently serves on the Appropriations, General Government, Judiciary and Rules Committees, as well as the Joint Committee on State-Tribal Relations.



The past four years of serving the residents of House District 79 has been an honor for Rep. Melissa Provenzano. When filing and running legislation, she prioritizes constituent requests and the concerns expressed to her during conversations with neighbors and the people of House District 79. She understands the importance of transparency and accountability in Oklahoma's public servants and centers those principles as she works to help Oklahomans overcome real problems.

Mark Lawson was first elected to the House of Representatives in 2016.

He believes the key to Oklahoma's prosperity begins with our families at home. His primary focus during his legislative service has been children and family issues. Mark has championed legislation to strengthen families and reduce childhood trauma.

Mark spent many years advocating for children and families before being elected. His work at the Youth Services of Tulsa's Safe Place program and the Children's Hospital at Saint Francis gave him firsthand experience of the struggles many of our families face. Mark also served as a CASA (Court Appointed Special Advocate) for abused and neglected children in Creek County and is a former chairman of the Youth Services of Creek County's board of directors.

Currently, Mark serves as Chairman for the Appropriations and Budget subcommittee for Human Services, which oversees 10% of the entire state budget. Additionally, he serves on the full Appropriations and Budget committee and the standing committees on Government Efficiency and Children, Youth & Family Services.

Mark holds a Bachelor of Science in Health Education from Oklahoma State University and is currently enrolled as a master's student at the University of Oklahoma in the Public Administration program.

Mark and his wife, Pam, have two wonderful children. Asher is a multiple sport athlete, and they welcomed their beautiful daughter, Ivy Ruth, in April 2020.



Governor Frank Keating is an attorney by training and a former partner of Holland and Knight. Formerly, he was the president and CEO of the American Bankers Association. The ABA is a 140-year-old association that represents banks of all sizes and charters and is the voice for the nation's \$13 trillion banking industry and its two million employees. Keating became ABA's president and CEO on January 1, 2011, and stayed through December 31, 2015, following seven years of service as the president and CEO of the American Council of

Life Insurers, and after serving two terms as Oklahoma's 25th governor.

Born in St. Louis, Frank grew up in Tulsa, Oklahoma. He received his undergraduate degree from Georgetown University and a law degree from the University of Oklahoma. His 30-year career in law enforcement and public service included service as an FBI agent; U.S. Attorney and state prosecutor; and Oklahoma House and Senate member, including service as a Republican senate leader.

He served Presidents Ronald Reagan and George H.W. Bush in the Treasury, Justice, and Housing departments. His Justice and Treasury service gave him responsibility for all federal criminal prosecutions in the nation and oversight over agencies such as the Secret Service, U.S. Customs, the Bureau of Alcohol, Tobacco and Firearms, U.S. Marshals, the Bureau of Prisons, and the Immigration and Naturalization Service and all 94 U.S. Attorneys. As assistant secretary of Treasury and general counsel and acting deputy secretary of HUD, Keating's work included housing finance, lending practices, securitization, and Bank Secrecy Act issues.

In 1993 Keating returned to Oklahoma to run for Governor. He won a three-way race by a landslide and was easily re-elected in 1998, becoming only the second governor in Oklahoma history to serve two consecutive terms.

As the governor of Oklahoma, Keating won national acclaim in 1995 for his compassionate and professional handling of the bombing of the Alfred P. Murrah Federal building in Oklahoma City. In the aftermath of the tragedy, he helped raise more than six million dollars to fund scholarships for the nearly 200 children left with only one or no parents. His accomplishments as Governor include winning a successful public vote on right-towork, tort reform, tax cuts, and major road building and education reform.

Keating is the chairman emeritus of the Board of the Washington based Bipartisan Policy Center and served on the Policy Center's Debt Reduction Task Force, a group of former cabinet members, elected officials and key stakeholders of both parties that recommended a series of tough measures to address the nation's fiscal challenges. He also served on the BPC's Housing Commission. He was previously chairman of the Advisory Board of Mt. Vernon and president of the Federal City Council. He also served on the boards of the National Archives, the Jamestown Foundation and as chair of the National Catholic Review Board. He is currently Chairman of the Board of Regents for the University of Oklahoma.

He is a Director of Hall Capital, Global Financial, Banc First Corporation and Citizens Life Insurance Company.

Keating also is the author of five award-winning children's books, biographies of Will Rogers, Theodore Roosevelt, George Washington, Abraham Lincoln, Standing Bear, the Ponca Indian chief who argued Native Americans deserve the same rights as white Americans and Alexander Hamilton. He is the recipient of six honorary degrees.

He and his wife Cathy live in Oklahoma City, OK. They have three children and eleven grandchildren.



David Walters is President of Walters Power International. Mr. Walters served as the Governor of Oklahoma from 1991 to 1995.

As Governor, David Walters presided over a \$7 billion organization that employed 135,000 people. Governor Walters reduced by attrition the number of state government employees for the first time in the history of the State of Oklahoma, aggressively promoted economic development, achieving a 15-year record in job growth. Governor Walters successfully op-

posed all tax increases and yet oversaw a 30% increase in education funding by reallocating budget dollars. Walters passed the first capital improvements bond issue in Oklahoma in 25 years, which invested over \$350 million dollars in the State's infrastructure. He advanced the first workers compensation insurance reform in 15 years, causing substantial rate reductions. Governor Walters led trade delegations to eight nations during his term. Oklahoma's international trade grew at twice the national average during his term in office.

At the conclusion of his term in office he entered the independent power industry. Walters has developed dozens of independent power projects. He has negotiated and signed agreements on projects in China, Dominican Republic, Haiti, Ecuador, Pakistan, India, the United Kingdom, Spain, Finland, France, Bulgaria, Poland and in several locations in the U.S. Since 1995, Walters has made over 200 international trips to 35 countries, traveling over 3,000,000 miles. Kenneth Corn has spent his entire adult life serving the people of Oklahoma. Elected at the age of 22 to the Oklahoma House of Representatives in 1998, he became one of the youngest individuals to serve in state history. Corn was tapped as vice chairman of the Revenue and Tax Committee making the first freshman lawmaker in thirty years at the time to be on the leadership of a major committee. He was selected as the Secretary of the Democratic Caucus and was later chosen to chair the House committee on Tourism and Recreation. In

addition, he was one of the members chosen to help redraw the House and Senate Districts in 2000 during the redistricting required by the Constitution.

In 2002 following the death of his mentor and friend Senator Larry Dickerson, Corn announced his intentions to seek the Senate seek for District 4. He was elected by the voters in Leflore and Sequoyah Counties with a margin of over 80 percent making him the second youngest person to serve in the Senate in state history. Corn was immediately tapped to head the Insurance and Retirement Committee in the Senate where he helped shape the state regulations of the insurance industry and set state policy on retirement for thousands of public sector employees. Corn was also chosen to represent the Senate as a state pension commissioner where he had oversight of billions of dollars in assets. During his tenure, Corn was honored by his election to serve as the Democratic Caucus Chair for the remainder of his service in the Senate. In addition, Corn was tapped to be the chair of the Senate Appropriations Sub-committee for Public Safety and Judiciary where he was considered a strong advocate for law enforcement and a good steward of taxpayers' dollars.

During his service in the Oklahoma Legislature, Corn was a driving force behind increasing teacher pay. His

efforts moved Oklahoma ever closer to the regional average at the time. Corn pushed the legislature to pass the Larry Dickerson Flexible Benefit Act providing 100 percent health insurance to school personnel throughout Oklahoma. In the Senate, Corn spearheaded the efforts to improve public safety which led to the largest appropriations in state history at the time. He tackled prison overcrowding and staffing shortages, additional academies to put more troopers of the street, and increased the pay of state law enforcement officials. Corn reformed the state's Council on Law Enforcement Education and Training with the passage of Senate 920 bringing the system into the modern realities of law enforcement. Corn recognized by law enforcement agencies and officials for his efforts. He was chosen by the District Attorney's Council, Oklahoma State Troopers Association, and the Oklahoma State Bureau of Investigations Director for multiple awards. In addition, Corn was the principal architect of the largest investment in Oklahoma's highway and bridges at the time.

In 2010, Corn returned home to Poteau where he worked in the oil and gas transportation industry. Corn has used his experience and education in government to make changes for the industry through work with state and federal agencies.

Corn was appointed to serve as City Manager of Anadarko, Oklahoma on March 31, 2005. At the time of his appointment, Anadarko had been operating in a deficit. Corn overhauled the City's purchasing process, billing systems and renegotiated contractual obligations, bringing the city back to financial stability and allowing significant investments in capital improvements.

Corn renewed partnerships with the federal, state, county and tribal governments that generated over \$8 million in grants awarded to Anadarko and completed large capital improvements for the city, including significant upgrades to city sidewalks, roadways, water and wastewater system, electric distribution system, landscaping, public art, and to Anadarko's parks. In addition, by gaining support of industries, local businesses and tribal governments, Corn developed festivals including Hoppy Day, Zombies-in-the-Park, Kids, Kites-and-Frights, and a traveling Easter Bunny and Santa, all free to the public.

During his tenure, Anadarko has withstood historic weather, including a "hundred-year flood," ice storms and record-breaking Arctic temperatures. During each crisis, Corn became widely acclaimed by Anadarko citizens for working on site with city crews and updating people via Facebook Live.

On February 24, 2022, Corn was appointed to serve as the United States Department of Agriculture (USDA) State Director for Rural Development in Oklahoma by President Joseph Biden, Jr.
